- 1. This certificate is valid on the condition that an annual surveillance audit is carried out and satisfactory to the Society.
- 2. The scope of services on this certificate is valid on a condition that the laboratory is accredited by KOLAS in its relevant scope of accreditation as listed on the Certificate no. KT815 issued on 9th February, 2023 by KOLAS.
- 3. The testing laboratory shall notify this Society for the following cases and an occasional assessment may be performed by this Society if deemed necessary.
 - Any significant changes to the approved quality system such as changing the test facility or in case where it is difficult to perform the test due to the change of test personnel; and/or
 - Any changes or additions to the approved test field or test laboratory.
- 4. Tests may be carried out without the attendance of a Surveyor of the Society, but it is to be verified by the person in charge of the laboratory that the test specimen is confirmed and sampled by the Society. For the purpose of the test specimen identification, the person in charge of the laboratory is to confirm that one of the below signs is marked on the specimen.









- 5. In case where there is any failure occurred during the test, it is to be informed to this Society without any delay for consideration of the test result as well as re-arrangement of the test specimen.
- 6. In case where other organizations especially request the witness test by a Surveyor or there is any problem with the reliability of the test results, a Surveyor may attend the test with a prior notice. Or whenever a Surveyor's attendance is deemed necessary by the Society, unscheduled visit by the Society is to be permitted.
